GENERAL. BALTICA is a peer-reviewed journal of geosciences and related environmental sciences published biannually: No. 1 in June and No. 2 in December. BALTICA publishes RESEARCH ARTICLES (up to 20 printed pages, including illustrations and references) and BRIEF REPORTS: REVIEWS (up to two pages), INFORMATION (up to one page) and BIBLIOGRAPHIES. English (UK) is the language of the journal.

COPYRIGHT ©. Upon acceptance of manuscripts for publication in the journal entitled BALTICA, authors are asked to transfer the copyright of their submitted articles to BALTICA, trading under the name of the State Scientific Research Institute Nature Research Centre.

SUBMISSION. [A] Manuscripts for publication in the journal BALTICA are accepted on a continuous basis by direct e-mail: **balticajournal@gamtc.lt**, or by using the automated submission system (https://baltica.gamtc.lt/lt/new-order). Further preparation of an article for publication involves e-mail communication between the journal's editor and the corresponding author.

All manuscripts submitted for publication in BALTICA should be accompanied by cover letters, in which the authors should state that the submitted research materials, including illustrations, are the products of original research and that they have not been published elsewhere before nor are currently under consideration by any other journal.

- [B] The text, tables and captions to figures should be presented as separate MS WORD files. Illustrations should be submitted according to the requirements below. The submitted manuscripts are subject to external peer review, following which the manuscripts, as a rule, are e-mailed back to their authors for revision and correction. Reviewers remain anonymous, unless they wish to be identified.
- [C] To be accepted for final publication in BALTICA, the submitted manuscripts must meet the international standards of academic English (UK) and be free of various language mistakes (grammar, spelling, style, punctuation, terminology, etc.). In this context, it must be emphasized that it is the authors of the articles that bear full responsibility for the quality of the language of the articles. If the language quality of a manuscript submitted by non-native speakers of English is highly questionable, the author may be required to provide an English editing certificate to prove that the manuscript has undergone language editing by an English language professional. Before publication, the language of submitted manuscripts must also pass a proofreading test by an English language editor (native or non-native), who is designated at the discretion of the journal's editorial board. Only the manuscripts that are recognized as linguistically correct by the language editors of the journal are accepted for final publication.
- [D] Any accepted manuscript will be sent as a PDF file to the corresponding author for proofreading. No changes or additions, except for corrections of minor spelling mistakes, are allowed in the manuscript after it has been proofread. After proofreading, the final version of the manuscript together with a scanned copyright transfer agreement signed by the corresponding author must be sent to BALTICA.
- [E] Accepted articles are available on an Open Access basis on the website of the State Scientific Research Institute Nature Research Centre. The authors of an article are entitled to at least one free copy of the printed journal issue.
- [F] If necessary (due to large size, etc.), a certain amount of article material can be published as **Supporting Online Material** (figures, tables, references, videos, etc.). This will be available only in the online version of the journal.
- **TEXT.** The manuscript should meet the following formatting requirements: 12 pt size Times New Roman font, A4 size sheet with a printable area of 18×24 cm, 1.5 line spacing and default margin setting. The manuscript should be arranged as follows:
 - [1]. The title of the manuscript should be short but informative.
- [2] The name(s) and surname(s) of the author(s) should be given in full. The corresponding author should be marked with an asterisk. Each co-author must indicate his/her own **ORCID** number (if he/she has such). **This is mandatory for the corresponding author**.
- [3] Abstract (up to 250 words) and a set of keywords (minimum 5 words). Please note that the keywords should not duplicate the words used in the title.
 - [4] Affiliation, institutional address(es) and e-mails of the co-author(s).
- [5] In the main body of the text, no more than **four** levels of **unnumbered headings and subheadings** should be used. Printing should start from the left margin. SI units and their standard symbols should be used consistently throughout the text.

Marginal notes (Fig., Figs, Table) should be given in the left blank space. References in the manuscript text should be given as follows: (Johnsson 1990), (Johnsson, Petersson 1990), and in case of three or more authors use (Petersson *et al.* 1990).

[6] The list of references should be arranged in alphabetical order according to authors' or editors' surnames. **The titles of journals and publications should be given unabridged.** References in Cyrillic or other non-Latin alphabets should be transliterated into the Latin alphabet and translated into English; the original language of the reference should be indicated in square brackets as follows: [In Ukrainian]. At the discretion of the author(s), references in the Latin alphabet can be translated into English as well. The publisher should be mentioned for books. Pages of reference sources should be given as follows: from—to for articles, and the whole number (pp.) for books. Websites should be indicated in the way it is in the Internet source.

- [7] Captions to figures should be numbered and stored as a separate file.
- [8] Table captions should be placed above the tables. Tables should be as simple as possible. Their number should be kept to a minimum, and they should be numbered in Arabic numerals.
- [9] Equations should be created using the Microsoft Equation Editor of Word 2003, or the Math function of Word 2007 or 2010.
 - [10] The rules to be adhered to when preparing the manuscript text file are as follows:
- The same elements should be keyed in exactly the same way throughout the manuscript; abbreviations should be clearly explained the first time they are used.
- The text should not be right-justified (left-justify option should be used instead).
- Non-breaking hyphens (-) should be used in compound adjectives preceding nouns.
- En-dash hyphens (-) should be used to indicate ranges and when the first part of a compound does not modify the second one.
- En-dash hyphens should be used to indicate page ranges in reference lists.
- Single spacing should be used after a full stop.
- The space bar should be used only as a word separator.

ILLUSTRATIONS. Figures should be prepared as separate files in JPEG, TIFF, PDF, WMF, EMF, EPS and EXEL formats and meet the following technical requirements:

- Resolution should be no less than 300 DPI.
- Picture width (for printing without magnification or reduction) should be 82.5 mm, 130 mm or 170 mm.
- Font Arial, the smallest font 6–8 pt (in special cases 5 pt).
- If there are sections inside the same figure (numbered: a, b, c, ...), the size of the letters used for numbering should not exceed 10–11 pt.

Maps and graphs should be presented with an indicated linear scale. The location of the study area on the map should be indicated by providing geographic coordinates. Avoid including figures and tables that require to be turned 90° to view. Tonal and colour illustrations are acceptable. The authorship of original illustrations (maps, drawings, etc.) should be indicated in respective captions.
